DOUGLAS J. RUTHVIN. Order passed that Douglas J. Ruthvin be re-employed commencing 11-15-35 as dairy inspector of Upshur Co. provided that he inspects all dairies in Upshur Co. and make proper reports to Commissioners Court. The salary to be at rate of \$25.00 per month - beginning Nov. 1, 1935.

GREGG CREOSOTING CO. Motion made, seconded and carried that warrant be issued to Gregg Creosoting Company on Auto #3 fund for the following described Creosote lumber 3x8x30 - \$27.00; 4x6x8 -- \$23.04; 1x8x12- \$7.66 total amount of warrant \$57.72.

CONDEMNATION PROCEEDINGS. In response to request of citizenship and to keep from losing W.P.A. project of \$15000.00 on road from Gilmer to Wood County line the Commissioners Court agreed to, at the proper time enter condemnation proceedings necessary to secure right of way from the 5 who have not donated right of way. This to be done when State accepts survey and agrees to build highway.
