WHEREAS, there are now outstanding and unpaid certain Common School District Bonds
 hereinafter described, and now owned by State Permanent School Fund, said bonds having hereto-
 fore been duly issued by this Court for and on behalf, of Common County Line School District
 No. 19, of said County; and

WHEREAS, the Commissioners Court of said County now deems it advisable and to the
 interest of said Common County Line School District that new bonds be issued in lieu of the
 following outstanding bonds;

THEREFORE, BE IT ORDERED, ADJUDGED AND DECREED BY THE COMMISSIONERS COURT OF
 UPSHUR COUNTY, TEXAS:

1. That the bonds of said Common County Line School District, to be called Common
 County Line School District No. 19 Refunding Bonds, be issued under and by virtue of the
 Constitution and Laws of the State of Texas, to the amount of \$3800.00, for the purpose of
 refunding; and canceling, and in lieu of a like amount of valid and outstanding indebtedness
 of Common County Line School District No. 19, of Upshur & Harrison County, Texas, evidenced
 by bonds as follows:
