Motion made, seconded and carried that Insurance on Court House and Jail be renewed to cover fire, tornado, explosion and plate glass for July 5, 1941 to July 5, 1944, to be insured by Aetna Fire Insurance Co. and Ohio Casualty Insurance Co. Co Clerk authorized to issue warrant on Gen. Fund for \$230. to cover the three year period.
