

July 12, 1941

Commissioners Court met on above date in Special Session with Co. Judge, Sid Buie and Commissioners E. A. Cobb, H. S. Taff, J.M. Holloway and G. L. Hart present

Motion made, seconded and carried that Grocery allowance of E. B. Proctor be raised to \$8.00 per mo.

Motion made, seconded and carried authorizing Co. Judge to advertise for bids for the building of Court House in Justice Precinct #5. Bids to be received until 10 A. M. Aug 11, 1941 and will be opened and publicly read.

Motion made, seconded and carried authorizing Co. Judge to advertise for bids for one Automobile for Sheriff's department. Bids to be opened at 10 A. M. August 11, 1941. One used Chevrolet to be traded in.

Motion made, seconded and carried that bids be opened and read for one Adams Motor Grader and one A. C. Tractor. Both bids duly tabled for consideration July 14, 1941.

July 14, 1941

Commissioners Court met in regular session on above date with Co. Judge Sid Buie, and Commissioners E. A. Cobb, H. S. Taff, J. M. Holloway and G. L. Hart present -

Motion made, seconded and carried that Correction of Minute made June 16, be as follows: That bid of McClure Harris be and hereby is accepted as lowest and best bid for the purchase of one W. S. Model A. C. Tractor at \$4150 and one used W K Model A. C. tractor traded in as part payment. Terms of payment on R & B #4 \$1400 cash payment on purchase date and balance payable in two time warrants dated April 1, 1942 and April 1, 1943, both warrants being made for \$1375, int. 3% per annum. Co. Clerk authorized to issue warrants.

Motion made, seconded and carried that in reference to bids opened on July 12, that after due consideration of above mentioned bid, One A. C. Model W S Tractor be and hereby is purchased from McClure-Harris Co. Tyler, Texas, being the lowest and best bid. Purchase price being \$4000. and one second hand A.C. W. K. Tractor taken in trade as part payment. Terms of payment cash to be drawn on Lateral road fund of Precinct #3. Co. Clerk authorized to issue warrants.

Motion made seconded and carried that in reference to bids opened on July 12, 1941, for One Motor Grader that after due consideration to above bid One Adams #501 Gas Motor Grader was purchased, it being the lowest and best bid. One used Austin Western traded in, leaving a net delivered price of \$4850. Terms of payment \$1650. cash at date of purchase and two time warrants issued to be paid: \$1600. Dec. 1, 1942 and Dec. 1, 1943. Int 3% per annum. Co. Clerk authorized to issue warrants on R & B #3 for above warrants.

July 18, 1941

The full Court sat as a board of equalization on above date and recessed until July 26, 1941.

The Court then canvassed the returns of the School Consolidation election of Harmony and Peach of Upshur and Wood Counties respectively. Motion made, seconded and carried that the result of the election be declared as follows: For consolidation - 17 votes
