The Court met for the purpose of opening bids for the Construction of a Co. Road from James to State Highway #26. The bid submitted by L. W. Pelphrey of Gladewater, Tex. being the lowest and best bid, motion was made, seconded and carried unanimously that bid of L. W. Pelphrey be accepted and contract awarded to said L. W. Pelphrey.

Motion made, seconded and carried that \$12,000 be transferred from Co. R & B fund to the various Prec't R & B funds, being \$3000 to be transferred to each of the Precincts. Namely: R & B 1, \$3000, R & B, 2 \$3,000, R & B 3, \$3,000 and R & B, 4, \$3000.

Motion made by E A Cobb seconded by H S Taff and voted unanimously that Upshur Co. ^{all} all of the hereunder stipulated Bonds authorized at a meeting of The Board of County and District Road Indebtedness, State of Texas at a July 14 meeting, 1943, authorizing the payment and State participation as hereunder set out.
