Motion made, seconded and carried that all County officials responsible for the collection of fines in Upshur Co. be requested to collect all fines so far as practical and to the best interest of Upshur Co. This conclusion being reached after discussing the recommendation made by the Grand Jury Sept. Term, 1943.

Motion made, seconded and carried that Co. Clerk be directed to notify all Co. and precinct officers responsible for the collection of fines in Upshur County that they follow the law as set out in C. C. D. 947 and Atty. Gen. Ruling #0-1792-1940, as to the proper division of said fines.

Motion made, seconded and carried that \$1993.76 be transferred from R & B fund to R & B #3 for the purpose of completing payment on building Seago Bridge. Same to be repaid \$1000 per year until paid. Co. Clerk authorized to make transfer.

Motion made, seconded and carried that Tax Collector furnish all necessary records and information to Co. Attorney for collection of delinquent taxes.

Motion made, seconded and carried that Co. Judge ascertain cost of erecting Honor Roll of all service men of the County same to be placed in the Halls of Co. Court house.

Motion made, second and carried that Treasurer Report for 3rd quarter be approved.
