DECEMBER 10, 1945.

Commissioners court met in regular session with all members present;

Motion made, seconded and carried that court cost as posted on returns made by properly qualified officers in service of Condemnation of right of way on highway No. 154; West of Gilmer, to Wood County line be paid. County clerk, authorized to issue warrant on R & B. Fund for same on presentation of proper returns on citations.

Motion made by M. O. Holmes, seconded by H. S. Taff that special .15% road tax and automobile registration money be divided as follows, R & B. #1; 35%, R. & B. #2, 10%, R & B. #3 25%, R. & B. #3 21%; Commissioners Holmes, Taff and McKinley voting aye, Commissioners, Cobb, Naye; the Motion carried, effective January 1st, 1946.

Motion made, seconded and carried that; The resignation of Mrs. Marie Robertson deputy Tax Assessor Collector be accepted and approved as of December 8th 1945.

Motion made, seconded and carried that application of E. R. Monk for use of County Machinery necessary to prevent soil erosion/ of farm land as requisition by U. S. Department of Agriculture be approved.

Motion made by Commissioners Cobb and seconded by Commissioners Taff and unanimously carried that certain U.S. Treasury notes purchased by Road District No. 1-A, Interest and Sinking fund. December 3, 1945 be sold \$45000.00 to Farmers and Merchants National Bank of Gilmer, Texas, \$45000.00 to First National Bank of Gilmer, and cancelled;

The County clerk is authorized to issue warrant on Road District No. 1-A, Interest and sinking fund for \$45000.00 in payment of the principal and warrant \$120.00 in payment of interest due, and that Bonds 10 to 18 inclusive of road District No. 1-A, be purchased from Farmers & Merchants National Bank of Gilmer, Texas; and cancelled;
The County clerk is authorized to issue warrant on road district No. 1-A, Interest and Sinking fund for \$45,000.00 in payment of principal and warrant for \$117.39 in payment of interest due.

Motion made, seconded and application of Allen McClelland for Louise Campbell to be appointed Deputy Tax Assessor-Collector at Salary of \$120.00 per month be approved and made effective Dec. 1st, 1945, Co. Clerk authorized to issue warrant on Salary Fund for same.
