Commissioners Court met in regular session with all members, Offie Nobles, J. W. Meadows, Charles Still, Floyd Drennan, and Everett Dean, present.

Motion was made by J. W. Meadows and seconded by Offie Nobles to designate a county road (for recording purposes only) to Lewis C. Robinson's land located in the Camp Joy area. A portion of this land is owned by the Federal Government and must have a road designation before the Robinson's are allowed to travel the road. The county will not maintain this road. Motion carried. (Copies of map attached)

Motion was made by Charles Still and seconded by J. W. Meadows to issue a right of way permit to Continental Telephone of Texas. The right of way will begin at the intersection of Aspen Trail and Sycamore. Motion carried. (Copy attached)

Motion was made by Charles Still and seconded by Floyd Drennan to issue a right of way permit to David A. Lynch to install a culvert on old Highway 80, 2 miles east of Big Sandy. Motion carried. (Copy attached)

Motion was made by J. W. Meadows and seconded by Floyd Drennan to send Everett Dean and Charles Still to the Revenue Sharing Rally in Washington D.C. on November 18, 1975. Motion carried.

Murrell Reynolds of Ore City and John D. Clinnard, Jr. or Pritchett met with the commissioners court to ask that their property tax be lowered. They were advised that taxes can only be lowered by the Board of Equalization which mets yearly in July. Both men will be notified by mail at least 10 days before the Board mets in July, 1976.

Wayne Toliver asked the court their position on Ronald Towery's salary concerning a 5% increase of salary given all other county employees. Mr. Towery was hired as a dispatcher on November 3, 1973 at a salary of \$440.00 per month under the Manpower Services and was not paid by the county. Manpower Services raised his salary to \$509 per month retroactive to November 3, 1973.

Motion was made by Charles Still and seconded by Floyd Drennan to approve Public Weighers bond of Richard Arbegast. Motion carried.
