Commissioners Court met in special session with J.W. Meadows, Charles Still, Floyd Drennan, and Judge Everett Dean. Judge Dean presided.

Judge Dean read the minutes of the January 17, 1977 meeting. Motion was made by Floyd Drennan, seconded by J.W. Meadows for the minutes to stand approve as read. Motion carried.

Motion was made by Judge Dean, seconded by J.W. Meadows to approve a permit application from Arkansas Louisiana Gas Company to place eight 3/4 inch gas lines in 2" casing within the right-of-way of Upshur County Road, Bluebird Lane. Motion carried. (Copy of Application attached.)

A motion was made by J. W. Meadows and seconded by Floyd Drennan to approve for recording in Plat records a plat of Stringfellow Park (addition to) in the John Sanders survey, A-438, Big Sandy, Texas. Motion carried. (recording purposes only).

Judge Dean received a letter from the Texas Historical Commission asking the court to appoint the Upshur County Historical Committee for the year 1977-78. Motion was made by J.W. Meadows, seconded by Floyd Drennan for this group to be approved for the Upshur County Historical Committee. Motion carried.

Judge Dean gave a report that Hollie McClain has agreed to pay Upshur County \$150.00 per month for the copies of records from Business Records, of the records of Upshur County. Motion was made by Floyd Drennan and seconded by J. W. Meadows for Mr. McClain to buy the Copies. Motion carried.

Cynthia Shattles asked that a Defensive Driving Class be sponsored by the Home Demonstration Club for four nights, February 8th, 10th, 15th, and 17th. The class will be two hours each night. There will be a \$5.00 enrollment fee. Motion was made by Judge Dean, seconded by J. W. Meadows that the classes may be given either in District Court room or County Court Room. Motion carried.

Motion was made by Floyd Drennan, seconded by J.W. Meadows to approve the unpaid bills. Motion carried.

Judge Dean made a motion, seconded by Floyd Drennan that Upshur County pay the expenses of those who attend the County Judges and County Commissioners annual workshop at Texas A&M on February 1, 2, 3. Motion carried.

Motion was made by J. W. Meadows, seconded by Floyd Drennan to adjourn. Motion carried.







NOW, THEREFORE, if the above bounden pledgor FARMERS & MERCHANTS NATIONAL BANK shall faithfully do and perform all the duties and obligations devolving on it by law as the county depository of UPSHUR County, and shall upon presentation pay checks drawn on it by the county treasurer of UPSHUR County, Texas; on "demand deposits" accounts in such depository, and all checks drawn upon any "time deposit" account upon presentation, after the expiration of the period of notice required in the case of "time deposits," and shall faithfully keep said county funds, and account for same according to law, and shall faithfully keep and account for all funds belonging to the county which are deposited with it under the requirements of Texas Revised Civil Statute's Annotated article 2547, and shall include State funds collected by the tax collector, and shall pay the interest at the time and at the rate hereinbefore stipulated on "time deposits", and shall, at the expiration of the term for which it has been chosen, turn over to its successor all the funds, property, and other things of value, coming into its hands as depository, then and in that event this contract is to be and become null and void and the securities above shall be returned to the pledgor, otherwise to remain in full force and effect, hereby specially authorizing the Commissioners' Court of UPSHUR County, Texas, to sell at public or private sale, with or without notice to the pledgor, the securities, or any part thereof, and apply the proceeds of sale to the satisfaction of any indebtedness arising by virtue of the violation of any or all the conditions of this contract.

The above provision is given in addition to any remedy the pledgee may have in any suit brought on this contract in any court in this State.

Any suit arising out of or in any way connected with this contract, shall be tried in the County of UPSHUR and State of Texas in any Court therein having jurisdiction of the subject matter thereof.




