Motion made by Charles Still, seconded by J.W. Meadows to request the Board of County and District Indebtness to return to Upshur County its share of lateral road funds (\$38,082.22) as of September 1, 1978. Motion carried. (Copy attached)

Floyd Drennan made motion, seconded by Charles Still to accept the bid from Allen Machinery Co., Inc. for a John Deere road grader with some modifications. Motion carried. (Copies attached)

Motion made by J.W. Meadows, seconded by Bernice Nobles to approve the unpaid bills. Motion carried.

Motion made by Charles Still, seconded by Floyd Drennan to approve Certificates of Obligations, Claim #19, 20, 21, 22, and 23 totaling \$65,000.00. Motion carried. (Copies attached)

KNOW ALL MEN BY THESE PRESENTS:

COUNTY OF UPSHUR X

WHEREAS, Bob Anderson is the owner of a 168.177 acre tract in Upshur County, Texas, said tract being more specifically described in a deed to Bob Anderson recorded in Vol. 389, Pg. 266 of the Deed Records of Upshur County, Texas; and

WHEREAS, Bob Anderson is to develop said 168.177 acre tract according to a uniform plan of development.








SURVEY PLAT TO SUBDIVIDE


