GILMER, TEXAS

March 10, 1986

Commissioners Court met in Regular Session with all members present.

Judge Dean dispensed with the reading of the minutes until later.

Janis Choate, District Extension Director, met with the Court requesting that milage at .20¢ per mile be separate from the salaries of Jerry Nickerson and Cynthia Shattles. She explained that there would be a maximum of \$240.00 per month per person. Motion by Gaddis Lindsey seconded by David Loyd to approve the request. Motion carried.

Motion by J. W. Meadows seconded by Paul Davis to extend acceptance of bids on used equipment until March 24, 1986. Motion carried.

Todd Gibbs met with the Court requesting a franchise agreement with the County to furnish garbage service for persons living outside city limits. He said that his firm would offer two services: garbage bag pickup at \$8.00 per month or an 82 gallon container for \$10.00 deposit and \$11.00 per month fee. Judge Dean told Mr. Gibbs that the County could not give a franchise. Motion by J. W. Meadows seconded by David Loyd to table the matter until March 24, 1986. Motion carried.

The Upshur County Librarian met with the Court and gave her report for the month of February, 1986. She said a Book Fair is being planned for the sale of surplus books donated to the library. She also informed the Court that the library is eligible for a computer at no charge except for the software from the North East Texas Library System.
