Tony Douglas with the extension service urged the court to keep the secretarial position in the extension office.




Motion by Gaddis Lindsey seconded by David Loyd to set the tax rate for 1992-93 at .5390/\$100. Motion carried. Copy attached.


Motion by Tommy Eatherton seconded by Tommy Stanley to adjourn. Motion carried.


UPSHUR COUNTY BUDGET


